

WSTNET Web Science Summer School 2019 (WWSSS'19)

Terms of participation

The event is organised by the Web Science Institute (WSI) at the University of Southampton.

The WSI [“the organiser”] was nominated by the Web Science Trust to host the WSTNET Web Science Summer School 2019 (WWSSS'19).

By registering for this event, you agree to the following terms of participation:

1. Registration

To register for the event you must fully complete the registration form available on the website. The contract takes effect when your registration is confirmed by the organiser. If your registration cannot be considered, the organiser will notify you accordingly.

2. Participant eligibility

By registering, you agree that you meet the relevant academic criteria to participate in this event.

By applying for a travel grant, you confirm that you meet the application criteria. You will be notified if your application has been successful or not. Following the event, you agree to provide suitable evidence of your travel arrangements.

3. Terms of payment

Unless otherwise agreed, you will pay the registration fee by debit or credit card through the University of Southampton Online Store by **Fri 9 August 2019**. If payment is not received by this date, the organiser is entitled to exclude you from participating.

4. Cancellation of registration

You may cancel your registration by notifying the organiser in writing at wsis@southampton.ac.uk. The conditions for reimbursement of any fees paid are as follows:

For cancellation notifications received by 9 Aug 2019	100% reimbursement
For cancellation notifications received between 10 Aug and 16 Aug 2019	50% reimbursement
For cancellation notifications received after 16 Aug 2019 .	No reimbursement

5. Cancellation of events

The organiser retains the right, in particular if there are insufficient registrations, to cancel events or make any necessary changes to provide suitable alternative activities.

6. Replacement of speakers

If the organiser is obliged to replace speakers or make changes to the programme, as long as the overall design of the event is not significantly affected, standard reimbursement conditions apply (See Item 4) should you choose to cancel your registration as a result.

7 Exclusion from participation

You are expected to abide by University of Southampton regulations for the duration of the event. The organiser is entitled to exclude participants from further participation in particular cases (e.g. payment default, disturbance of the event and operations).

8. Data protection and retention

By registering, you give the organiser permission to record, store and share your personal data solely for the purposes of the administration of this event.
